Climate Action Policy of Azerbaijan State University of Culture and Arts (ASUCA)

Vision

Objectives

1. Reduce Carbon Footprint: Achieve measurable reductions in greenhouse gas emissions from university operations, transportation, and energy consumption.

2. Promote Sustainable Practices: Integrate sustainability into the university's curriculum, research initiatives, and operational procedures.

3. Raise Awareness and Education: Foster a culture of environmental awareness and responsibility among students, faculty, and staff through targeted educational programs and campaigns.

4. Strengthen Partnerships: Collaborate with local, national, and international organizations to share best practices, resources, and experiences in climate action and sustainability.

5. Support Research and Innovation: Stimulate research initiatives that address the challenges of climate change and foster the development of innovative solutions.

Strategies

1. Sustainable Campus Initiatives
